Internship Eligibility

The general/common criteria to be eligible to be a part of our Internship Program are,

- You must be a regular or distance student in any of the recognised college or universities in India or Abroad
- Should show highest standards of creativity with just the required knowledge
- Ability to perform under stringent timeline, extreme pressure and constant follow-ups
- You have to submit a NOC from your institution for your full time engagement as an intern for a specified time from your institution.
- Good understanding of use of computer system, particular Internet and Office Suits
- A laptop with high speed internet connectivity is a must

Hurrey! I possess the desired requirement! Yes you are most welcomed to be a part of our internship program. The specific backgrounds we are looking for different roles are as below:

- 1. Creative Intern (Graphics Development, Content Development)
 - Streams: Fine Arts, Computer Graphics, Designing, Editing, Arts, English
 - Knowledge: Use of various editing tools, copyrighting, editing, English grammar, etc.
- 2. Developer Intern (Desktop and Web Portals, Apps, Website Design, etc.)
 - Streams: IT, Computer Science, Computer Diploma and Other relevance fields
 - Knowledge: Programming Languages, Scripting Languages, Web Programming, Use of various IDEs, User interface Design, etc.
- 3. Marketing Intern (Sales, Branding, Marketing)
 - Streams: Management, Sales, Designing
 - Knowledge: Detailed understanding of online world, Sales Acumen, Marketing Strategy, Branding Guidelines, etc.

NOTE: This list of eligibility is indicative and we can consider any student fit to our requirements.

PractoMind Selection Process

We follow a a stringent selection process consisting of **Pre-Internship-Talk (PIT)**, **Knowledge Assessment Test (KAT)**, and **Uncommon Interview (UI)**, we collectively call it as "**PKU-Perfect Knowledge Utilization**". We expect the institute to provide a list of short listed candidates based on Company's requirements.

1. Shortlisting

We approach selected campuses and provide our requirements to the institute to send us a list of eligible and shortlisted students.

2. Pre-Internship-Talk (PIT)

Pre-Internship-Talk (PIT) is all about what you have read above with an additional info about what your life is going to be at PractoMind Solutions presented with the help of a graphical presentation by our senior management team.

Believe us we will make your life a hell during your association and will guarantee you to have real learning to make real difference.

3. Knowledge Assessment Test (KAT)

There is nothing to fear about the KAT. It is a short and simple test of about 30 minutes containing both objective and subjective questions to check the basic level of your knowledge and eliminates 70% of shortlisted candidates. Please don't ask the evaluation criteria. It's a secrete we want to keep.

4. Uncommon Interview (UI)

The reason we call it Uncommon Interview and UI has some sense that will be asked to you during the PIT or UI. Be prepared for the same.

There is no certain or specific guidelines to the process of UI and you can expect any funny or silly questions. Only one advice to keep in mind during the UI is not to think much.

NOTE: You are free to withdraw your candidature at any stage of the selection process. The selection process will take one day time and conducted at your campus during Saturday or Sunday and results are declared on the next day.

Post Selection

Post your selection the same will be communicated to you and your institution and you will be given a time frame to join us in consultation with your institution.

Post joining you will be issued Letter of Internship stating the detailed terms and conditions. Upon your acceptance of the Internship Letter you will be provided the designation of an Intern and can start enjoying full benefits.

We will put you to various projects or assign specific tasks to perform.

Intern Evaluation

You will be reviewed constantly by the organisation and we will keep an eye on every activity you do. You have to comply the following during your internship period to be able to be evaluated and certificate issuance.

- 95% of attendance is mandatory
- Submission of regular progress reports in specified format as and when directed
- 100% compliance to policies and norms
- Submission of final internship report
